Live Auction

Guests will purchase "keys" (\$100/raffle ticket) and one lucky winner will take home the contents of the closet – a collective bounty of donated fashion items, products and various treasures. Product donations may include, but are not limited to: art, furniture, home accessories, fashion merchandise, gift cards (retail, spa, restaurant, travel), etc. Ideal for donations valued at \$100 or more. All donors and their items will be listed in the program and on Key to The Closet signage.

Mystery Bags

Guests will pay \$50 to pick a gift bag whose contents are a mystery. Product donations can be anything valued \$25-\$150.
